Marijuana Policy

- Phoebe:
 - Recent 3 hour training for BOH members draft local regs were unveiled.
 Phoebe is available to help towns think about this. Phoebe provided a hard copy of draft local regs that towns can choose from many recommendations are doubling upon CCC regulations locally a menu of options including:
 - raising minimum age included as an option no one has done it yet but decided to include it (similar to tobacco 21) since brain continues to develop until mid-twenties.
 - "food is food" reg can apply if BOH says it is in your town...every town will need to pass something that says this. This means that edible marijuana products would be subject to inspection.
 - banning loose rolling
 - housing can ban the smoking of MJ, shouldn't try to ban growing
 - o committee to address drugged driving/drug-free workplace is forming
 - Question that arose Is CBD oil regulated the same way as THC products?
 - Hemp regulations coming soon too
- Laurie:
 - Heard that it's worth looking at the regulations in Hull and Brookline
- Ilana:
 - Shared her handout feel free to use/adapt
 - Patriot Care to expand to recreational MJ in Greenfield
- Kara (about recent meeting and hearing in Montague re: proposed MJ business)
 - \circ 253 Organic LLC public hearing for site review and public outreach meeting
 - Vertically integrated craft cooperative license
 - Proposing to use old Hallmark facility; want to open retail ASAP to help fund growing
 - They agreed to open at 9 instead of 8 to avoid the spectacle of cars lined up outside as kids go to school
 - Rick Martin sent a letter that he didn't think it would be good for students the location is super-close to schools
 - o 250 lbs of MJ/month when operation in full swing
 - Diversion-prevention: sounds like limited to ID-ing customers
- Group discussion Can we have some kind of process where after one of these meetings someone (P&PC? CTC?) will send a letter to Selectboard with the things we would want to see in their host agreement. Would have to be done quickly!

Upcoming workshop by Phoebe Walker on working with local governments
